Butch to proceed with developing critical incident reporting method for CARR.

Agenda item: House of Light grievance

Discussion:

Butch – In state of Colorado, law on marijuana is a constitutional right. What is CARR’s position on legal consumption of marijuana in recovery residences.

Cali – Do they have medical marijuana cards? If they don’t? How is this different than suboxone?

Butch – Definition of a recovery residence is free from alcohol and unprescribed drugs.

Butch – SB202 funding is not federal? Block funding is federal.

Conclusions:

Is CARR allowed to interpret the statute to NOT allow marijuana? Amy will look into this with AG’s office.
